LSOA = Lower Super Output Area. All data available at OA level is also available for LSOAs. There are 449 LSOAs in Suffolk, with an average usual resident population of just under 1,700 people.

MSOA = Middle Super Output Area. There are 90 MSOAs in Suffolk, with an average usual resident population of just under 8,500 people.






Summary

- On the day of the 2021 Census, the usual resident population of Suffolk is estimated at 760,688.
- This is an increase of just over 32,525 (4.5%) since the 2011 Census; the equivalent of the current population of the towns of Stowmarket and Beccles combined.
- Since the 2001 Census, the population of the county has increased by just over 92,000 people (13.8%), approximately the current population of Lowestoft and Bury St Edmunds combined.



- The 2021 Census shows that the population of children and young people below the age of 20 in the county has fallen by around 5,800 since 2011, a 3.5% decrease. The under 20 population of Suffolk is now lower than it was in 2001.
- The working age population (20 to 64 in this case) has increased slightly (1.0%), with just over 4,000 more people in this age group compared to ten years ago.
- The Suffolk population aged 65 and over has risen considerably over the past decade. There are now 34,000 more residents in the county aged 65+, an increase of 23.6%. This is roughly equivalent to the combined current population of Felixstowe and Hadleigh. The 65+ population of Suffolk is 46% higher in 2021 than it was in 2001.




Chart 3: All usual residents by single year of age in Suffolk: 2011 and 2021 Censuses

Age and sex: five-year age band pyramids

The age pyramids below compare the percentage of the total population by five-year age group by sex for 2011 and 2021 Censuses for Suffolk and our Districts and Boroughs.




Chart 4: All usual residents by 5-year age band in Suffolk by

- The age pyramid above shows that Suffolk's overall population has aged from 2011 to 2021.
- Most five-year age bands below the age of 50 account for a smaller percentage of the overall proportion in 2021 than they did in 2011, while the opposite is true of the age bands over 50.
- Some larger age cohorts have a clear impact on the age pyramid as time passes by. For example, the 40-49 year old cohort accounted for among the highest percentages of the overall Suffolk population in 2011, while in 2021 this cohort is now impacting on the 50-59 age group. Meanwhile the 40-49 age group now accounts for a much smaller proportion of residents in the county.
- In other cases, smaller cohorts in 2011 have not fed through to the composition of the population in 2021. For example, the 20-24 age band accounted for around 5% of the population in 2011, but the 30-34 age group in the county is larger in 2021 and accounts for more than 6% of the total population of Suffolk due to migration into the county.
- The age pyramids for Suffolk's Districts and Boroughs are presented on the following pages. • Babergh, East Suffolk and Mid Suffolk have a particularly "pinched" lower-middle, the result of an older population and a lower proportion of young adults in particular. These areas also have a notably ageing population, with the older age bands accounting for a larger proportion of the overall population in 2021 than they did in 2011.
- Ipswich and West Suffolk have a more traditionally pyramid shaped chart, with a larger • proportion of working-age people and children.





Chart 5: All usual residents by 5-year age band in Babergh by gender, 2011 and 2021 Censuses

Chart 6: All usual residents by 5-year age band in East Suffolk by gender, 2011 and 2021 Censuses







Chart 7: All usual residents by 5-year age band in Ipswich by gender, 2011 and 2021 Censuses

Chart 8: All usual residents by 5-year age band in Mid Suffolk by gender, 2011 and 2021 Censuses







Chart 9: All usual residents by 5-year age band in West Suffolk by gender, 2011 and 2021 Censuses

- There are around 200 usual residents per square kilometre in Suffolk, half the England and Wales average.
- Population density has increased across all of Suffolk's Districts and Boroughs.
- The population density of Mid Suffolk remains the lowest in the county (118 people per square kilometre) but saw the highest increase over the past decade (7.3%). Mid Suffolk was the only district in Suffolk to see an increase in population density above the England and Wales average
- Of Suffolk's Districts, only the largely urban Borough of Ipswich has a higher-than-average population density.
- Across the county as a whole, there are 8.6 more usual residents per square kilometre in 2021 than there were in 2011, an increase of 4.5%.

Living arrangements

The "living arrangements" classification combines responses to the question on marital and civil partnership status with information about whether or not a person is living in a couple. This topic is only applicable to people in households (i.e. not those living in communal establishments). Living arrangements differs from marital and civil partnership status because cohabiting takes priority over other categories. For example, if a person is divorced and cohabiting, then in results for living arrangements they are classified as cohabiting.

Household estimates



It must contain someone whose place of usual residence is at the address. A group of short-term residents/visitors living together is not classified as a household.



- There are 22,798 more households in Suffolk at the time of the 2021 Census than there were in 2011, an increase of 7.3%
- The rise in household numbers has been higher in Suffolk than across England and Wales as a whole from 2011 to 2021
- The growth in households has been strongest in percentage terms in West Suffolk and Mid Suffolk. Babergh also saw household growth above the national average over the past decade.
- Household growth has outstripped population growth across most of Suffolk; the exception being lpswich. This reflects the increase in single person households.

- The number of households in Suffolk has increased by almost 23,000 (7.3%) from the 2011 Census to the 2021 Census.
- Most household composition definitions have increased during this period.
- Single person households have increased by 15.5% overall, with a slightly larger proportional increase in households containing one person of retirement age. In 2011 the figure presented is for 65 years and over, while in 2021 it is 66 years and over. This reflects the increases to state pension age.
- Married or civil partnership couples with no children or dependent children have declined over the last decade. This is partly due to the ageing population but also the rise in cohabiting couple families.
- Overall, married or civil partnership couple households have declined by 9,201 (8.3%), while cohabiting couples have increased by 7,006 (21.8%) and lone parent households have increased by 2,822 (10.3%).
- The number of households with non-dependent children has increased by 4,428 (16.2%) in the past decade. Just over half of this increase has occurred in lone parent families.
- Households containing only a person or people aged 66 and over have increased by almost a fifth since 2011, with almost 15,000 more such households in the county in 2021.



- There are almost 14,000 more single person households in Suffolk in 2021 than there were in 2011, an increase of 15.5%. Single person households account for more than half of the total increase in households in the county during this period.
- There have also been smaller increases (both in absolute and percentage terms) in 2 person, 3 person and 6+ person households in the county overall.
- Single person households account for 31.2% of all households in the county in 2021, an increase of just over two percentage points since 2011.
- All other household sizes have declined as a proportion of total households during this period in Suffolk.
- Across England and Wales there has been a more consistent increase across all household sizes. The dominance of the increase in single person households seen in Suffolk is not reflected across England and Wales as a whole.

• There are significant variations in changes in household sizes across Suffolk's Districts and Boroughs between the 2011 and 2021 Censuses.

- The number of larger households has declined across most of Suffolk. This ties in with the decrease in children and young people and families with children in in the county. The exception to this is Ipswich, where percentage growth from 2011 to 2021 is increasingly higher the larger the number of people there are in the household. Households with 4 or more inhabitants account for 19.3% of total households in Ipswich, around 17% in Babergh, Mid Suffolk and West Suffolk and 15.5% in East Suffolk.
- Single person households increased by almost a third in West Suffolk from 2011 to 2021, almost double the change seen in any other District or Borough area.

Households by deprivation dimensions

The dimensions of deprivation used to classify households are indicators based on the four selected household characteristics:

1. Employment: any member of a household not a full-time student is either unemployed or long-term sick.

2. Education: no person in the household has at least level 2 education, and no person aged 16-18 is a full-time student.

3. Health and disability: any person in the household has general health 'bad or very bad' or has a long-term health problem.

4. Housing: Household's accommodation is ether overcrowded, with an occupancy rating -1 or less, or is in a shared dwelling, or has no central heating.

Each household is classified as being deprived in none or one to four of these dimensions, and is only classified to one of the five options.

- According to this measure, the percentage of Suffolk households that are not deprived in any dimension has increased by over 25,000 (18.4%) between 2011 and 2021.
- Overall, the number of households in Suffolk that are deprived in any dimension has fallen by 2,315 (1.3%).
- While the number of households in Suffolk that are deprived in one dimension has increased by 12,274 (11.7%). However, there are also more than 12,000 fewer households that are deprived in two dimensions, 2,000 fewer that are deprived in three dimensions and 463 fewer that are deprived in four dimensions in the county.
- A larger proportion of Suffolk households (35.1%) are deprived in one dimension than across England and Wales as a whole (33.5%). Households experiencing two or more deprivation dimensions account for a smaller percentage of households in Suffolk than across the country.
- The data does not give a breakdown of which dimension households are deprived in. Unemployment levels in Suffolk were relatively high at the time of both the 2011 and 2021 Censuses (6% and 5% respectively). Adult skill levels in Suffolk have seen sustained improvement over the past decade and more, so it is likely that households deprived in this dimension in the county have declined. We can see from the household size data included in this Census release that the most significant growth has been in single person households, so relatively speaking overcrowded households will have declined. However,

the increase in people living alone could cause other concerns such as loneliness and social isolation.




- At the time of the 2021 Census, 81,142 people usually resident in Suffolk had arrived in the UK from abroad.
- The most common age group of people who are now living in the county having arrived from abroad were working-age people with young families. The 20-44 age group accounted for 54% of new UK arrivals settled in the county at this point in time, a slightly higher proportion than in 2011.
- Population growth among people born in the UK was 1.7% between 2011 and 2021.
- This data shows the age of people when they arrived in the UK, not their current age at the time of the Census.




Chart 14: All usual residents in Suffolk by age of arrival (excluding residents born in the UK), 2011 and 2021 Censuses

- There has been an increase in the number of residents that have arrived in the UK in all age groups and across all Districts and Boroughs.
- In Babergh, East Suffolk and Mid Suffolk, the proportion of the resident population that have arrived in the UK from another country has increased by around one percentage point from 2011 to 2021.
- In Ipswich, the percentage of residents that arrived in the UK from abroad is six percentage points higher in 2021 than it was in 2011. In West Suffolk, there has been a 3.4 percentage point increase in the resident population that arrived in the UK from abroad.

- By grouping some countries together it is possible to compare country of birth figures with the 2011 Census, when data were released for a less granular breakdown of countries.
- There were 11,281 more Suffolk residents born in the UK in 2021 than there were in 2011, an increase of 1.7%.
- From 2011 to 2021, the number of Suffolk residents born outside the UK increased by 21,242 (35.5%).
- People born in EU countries other than the EU14 accounted for around half of the growth in Suffolk residents born outside the UK between 2011 and 2021.



- At the time of the 2021 Census, 95% of Suffolk's population was either born in the UK or has been resident in the UK for more than 10 years. This is a very similar level to 2011.
- Of the 39,372 Suffolk residents who had lived in the UK for less than 10 years on Census day 2021, there was an even split between those who have been in the UK for between 5 and 10 years, 2 to 5 years and less than 2 years.



Non-UK short-term residents

A Census short-term UK resident is anyone born outside of the UK who, on 21 March 2021, had stayed or intended to stay in the UK for a period of three months or more but less than 12 months.

This data classifies a person according to the passport or passports they held at the time of the Census. This included expired passports or travel documents people were entitled to renew. Where a person recorded having more than one passport, they were counted only once, categorised in the following priority order: 1. UK passport, 2. Irish passport, 3. Other passport. Only the first country written in "Other passport" was taken.

In 2011, the total number of passports held exceeds the number of usual residents as the Census data accounted for people holding more than one passport.

Some countries have been grouped (particularly from the 2021 Census outputs) to allow comparison with 2011 figures.

- There were 32,959 more UK passport holders living in Suffolk in 2021 than there were in 2011.
- In 2021 there were 14,021 more holders of other European passports resident in Suffolk than there were in 2011, an increase of nearly 80%. The equivalent increase in holders of other European passports across England and Wales was slightly lower at 76.7%.
- The number of Suffolk residents holding almost all other passports declined during this period.
- This could be due to people who were not born in the UK successfully applying for a UK passport, which would then become their only passport recorded in this dataset.
- 136,517 Suffolk residents did not have a passport at the time of the 2021 Census. British nationals can apply for an adult passport when aged 16 (or will be in 3 weeks). There were 130,327 residents aged under 16 in the county on Census day, but we cannot be sure if the vast majority of those without a passport are children or not as the detailed data on passports held (e.g. by age) has not yet been released.

- Since the last Census, there has been a fall in the number of Suffolk residents that arrived in the UK in every decade before 2011.
- The largest drop, in both absolute and percentage terms, is in the decade from 2001 to 2011. There are almost 15,000 fewer Suffolk residents that arrived in the UK during this period (43%). There was also a 28.6% fall in residents across England and Wales that arrived in the UK during this 10-year period, so while part of this fall may be accounted for by people leaving Suffolk, it is likely that much of it is due to people leaving the country altogether.
- Residents that came to the UK in the earlier decades displayed here could now be at least 60 or 70 years old, so the decline in these numbers may be due to people coming to the end of their lives.
- A broadly similar number of Suffolk residents arrived in the UK in the decade prior to the 2021 Census (39,807) as arrived in the same length of time before the 2011 Census (34,594).
