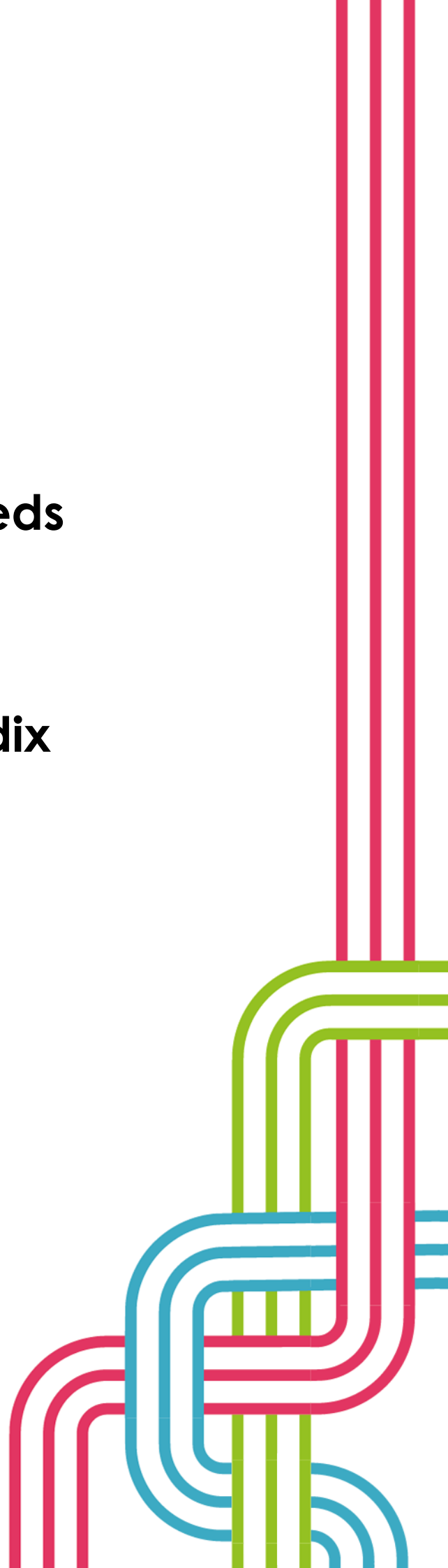

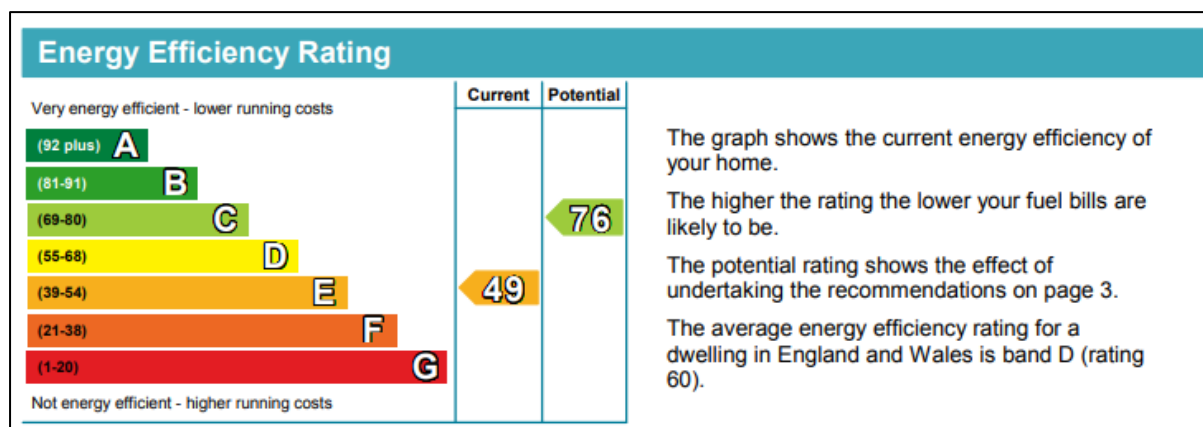

Figure 63. Example Energy Efficiency Rating (EER) from an Energy Performance Certificate

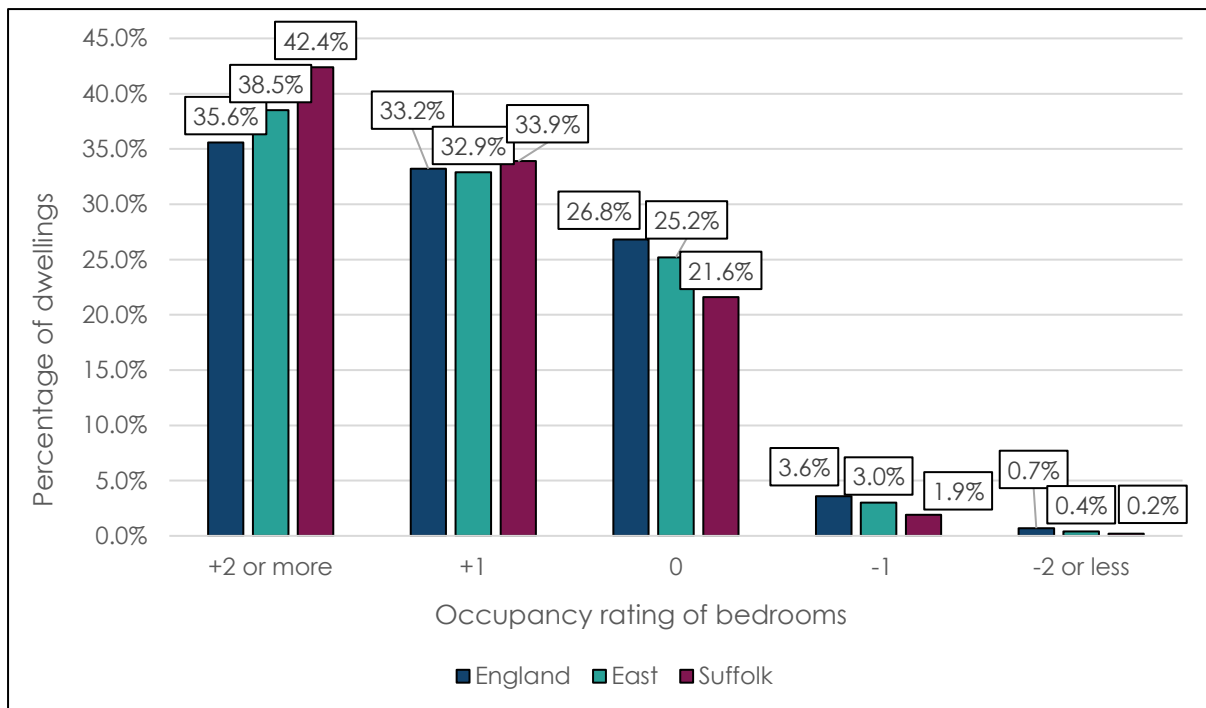

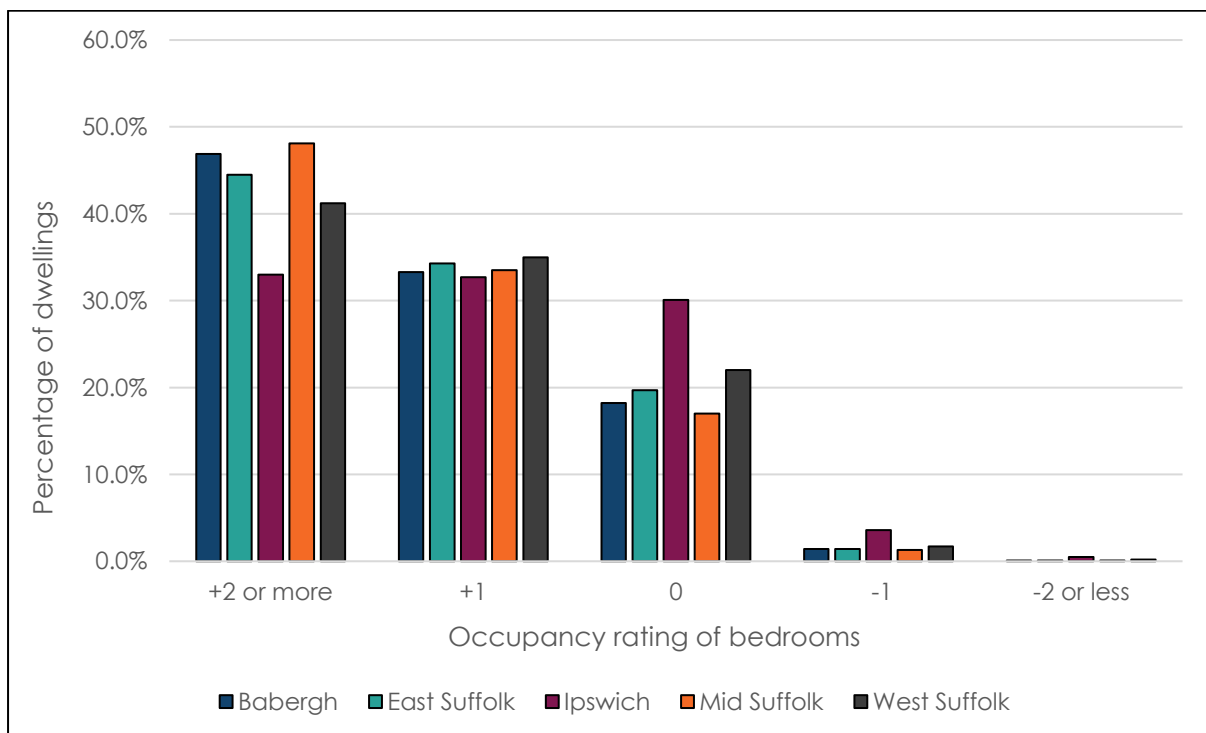
